



## Minimum pre-training required for

## IFRC Rapid Response deployments and trainings

## **Overview**

The aim of this list is to provide guidance to Rapid Response personnel and those wishing to develop into one, on minimum required courses in order to be deployed or accepted to face-to-face trainings.

Since the list is rather extensive, we advise to distribute it with networks on a regular, recurring basis and encourage relevant people to start taking the courses well in advance of a planned deployment or application for a face-to-face training.

This list has been agreed on with all IFRC regions and is recommended to Rapid Response members (previously called FACT, RDRT or RIT) and ERU Team Leaders. For ERU members this is recommended, but not mandatory.

The Surge mechanism contributes to **capacity enhancement** and support existing disaster preparedness initiatives.

Stakeholders commit to working together towards **operational excellence** where not achieved. The Surge mechanism will **monitor quality, learn, and optimise.**
